

I Maxwell's equations in various units

① SI units

$$\vec{\nabla} \cdot \vec{D} = \rho$$

$$\vec{\nabla} \cdot \vec{B} = 0$$

$$-\vec{\nabla} \times \vec{E} = \frac{\partial}{\partial t} \vec{B}$$

$$\vec{\nabla} \times \vec{H} = \frac{\partial}{\partial t} \vec{D} + \vec{J}$$

$$\vec{D} = \epsilon_0 \vec{E} + \vec{P}$$

$$\vec{H} = \frac{1}{\mu_0} \vec{B} - \vec{M}$$

$$\mu_0 = 4\pi \times 10^{-7} \frac{\text{Tesla} \cdot \text{meter}}{\text{Ampere}}$$

$$c = 299729458 \text{ m/s (exact)}$$

$$\epsilon_0 \mu_0 = \frac{1}{c^2}$$

Lorentz force law

$$\vec{F} = q [\vec{E} + \vec{v} \times \vec{B}]$$

② Gaussian units

$$\vec{\nabla} \cdot \vec{D} = 4\pi \rho$$

$$\vec{\nabla} \cdot \vec{B} = 0$$

$$-\vec{\nabla} \times \vec{E} = \frac{1}{c} \frac{\partial}{\partial t} \vec{B}$$

$$\vec{\nabla} \times \vec{H} = \frac{1}{c} \frac{\partial}{\partial t} \vec{D} + \frac{4\pi}{c} \vec{J}$$

$$\vec{D} = \vec{E} + 4\pi \vec{P}$$

$$\vec{H} = \vec{B} - 4\pi \vec{M}$$

Lorentz force law

$$\vec{F} = q \left[\vec{E} + \frac{\vec{v}}{c} \times \vec{B} \right]$$

(2)

(3) Lorentz Heaviside units

$$\vec{\nabla} \cdot \vec{D} = q$$

$$\vec{\nabla} \cdot \vec{B} = 0$$

$$-\vec{\nabla} \times \vec{E} = \frac{\partial}{\partial t} \vec{B}$$

$$\vec{\nabla} \times \vec{H} = \frac{\partial}{\partial t} \vec{D} + \vec{J}$$

Lorentz force law

$$\vec{F} = q \left[\vec{E} + \frac{\vec{v} \times \vec{B}}{c} \right]$$

(4) Conversion

$$\vec{D}_G = \sqrt{4\pi} \epsilon_0 \quad \vec{D}_{SI} = \sqrt{4\pi} \vec{D}_{LH}$$

$$\vec{E}_G = \sqrt{4\pi} \epsilon_0 \quad \vec{E}_{SI} = \sqrt{4\pi} \vec{E}_{LH}$$

$$\vec{H}_G = \sqrt{4\pi} \mu_0 \quad \vec{H}_{SI} = \sqrt{4\pi} \vec{H}_{LH}$$

$$\vec{B}_G = \sqrt{4\pi} \mu_0 \quad \vec{B}_{SI} = \sqrt{4\pi} \vec{B}_{LH}$$

$$\vec{D} = \vec{E} + \vec{P}$$

$$\vec{H} = \vec{B} - \vec{M}$$

II Statement of conservation of charge

① In SI units we know.

$$(i) \quad \vec{\nabla} \cdot \vec{D} = q$$

$$(ii) \quad \vec{\nabla} \cdot \vec{B} = 0$$

$$(iii) \quad -\vec{\nabla} \times \vec{E} = \frac{\partial}{\partial t} \vec{B}$$

$$(iv) \quad \vec{\nabla} \times \vec{H} = \frac{\partial}{\partial t} \vec{D} + \vec{J}$$

$$\vec{D} = \epsilon_0 \vec{E}$$

$$\vec{H} = \frac{1}{\mu_0} \vec{B}$$

$$\vec{F} = q [\vec{E} + \vec{v} \times \vec{B}]$$

② Using ① - (i)

$$\frac{\partial}{\partial t} \vec{\nabla} \cdot \vec{D} = \frac{\partial \rho}{\partial t}$$

③ Using ① - (iv)

$$\vec{\nabla} \cdot \vec{\nabla} \times \vec{H} = \vec{\nabla} \cdot \frac{\partial}{\partial t} \vec{D} + \vec{\nabla} \cdot \vec{J}$$

$$0 = \vec{\nabla} \cdot \frac{\partial}{\partial t} \vec{D} + \vec{\nabla} \cdot \vec{J}$$

← Prove explicitly
 $\vec{\nabla} \cdot \vec{\nabla} \times \vec{H} = 0$
 $\epsilon_{ijk} \nabla_j \nabla_k = \epsilon_{ijk} [\nabla_j \nabla_k + \nabla_k \nabla_j] \frac{1}{2}$
 $\epsilon_{ijk} \nabla_j \nabla_k = (\epsilon_{ijk} - \epsilon_{ikj}) \frac{1}{2} \nabla_j \nabla_k$
 $= 0$

④ Using ② & ③

$$\frac{\partial \rho}{\partial t} + \vec{\nabla} \cdot \vec{J} = 0$$

over a volume bounded by surface S.

⑤ Integrating ④ over a volume bounded by surface S.

$$\frac{\partial}{\partial t} \underbrace{\int_V d^3x \rho(\vec{x}, t)}_{Q(t)} + \int_V d^3x \vec{\nabla} \cdot \vec{J} = 0$$

$$\frac{\partial}{\partial t} Q(t) + \oint d\vec{a} \cdot \vec{J} = 0$$

III Electric and magnetic potential

① $\vec{\nabla} \cdot \vec{B} = 0$

A sufficient condition for the solution is

$$(\because \vec{\nabla} \cdot \vec{\nabla} \times \vec{A} = 0)$$

$$\vec{B} = \vec{\nabla} \times \vec{A}$$

② Is $\vec{A}(\vec{x}, t)$ unique? No.

sourcen-less (homogeneous)

$$\vec{B} = \vec{\nabla} \times \vec{A} \quad \text{in the other}$$

③ Using

equation we get

$$\vec{\nabla} \times \vec{E} + \frac{\partial}{\partial t} (\vec{\nabla} \times \vec{A}) = 0$$

$$\vec{\nabla} \times \left[\underbrace{\vec{E} + \frac{\partial \vec{A}}{\partial t}}_{= -\vec{\nabla} \phi} \right] = 0$$

④ Again, a sufficient requirement is:

$$(\because \vec{\nabla} \times \vec{\nabla} \phi = 0)$$

$$\vec{E} + \frac{\partial \vec{A}}{\partial t} = -\vec{\nabla} \phi$$

is a conventional choice.

⑤ → the negative sign in ④ is in ④

→ Is $\phi(\vec{x}, t)$ unique? No.

⑥ Thus, we have

$$\vec{B} = \vec{\nabla} \times \vec{A}$$

$$\vec{E} = -\vec{\nabla} \phi - \frac{\partial \vec{A}}{\partial t}$$

$\vec{A}(\vec{x}, t) \rightarrow$ magnetic vector potential

$\phi(\vec{x}, t) \rightarrow$ electric scalar potential

IV Gauge transformations (non-uniqueness of ϕ and \vec{A})

- ① - \vec{E} and \vec{B} are physical quantities
- ϕ and \vec{A} are mathematical constructs.
- Quantum mechanics is based on the Hamiltonian,
- Quantum mechanics is written in terms of ϕ and \vec{A} .
- Aharonov-Bohm effect (1959) suggests that ϕ and \vec{A} might have experimental signatures.

② Let

$$\left. \begin{aligned} \vec{A}' &= \vec{A} + \vec{\nabla} \lambda(\vec{x}, t) \\ \phi' &= \phi - \frac{\partial}{\partial t} \lambda(\vec{x}, t) \end{aligned} \right\} \text{— Gauge transformation.}$$

③
$$\begin{aligned} \vec{B}' &= \vec{\nabla} \times \vec{A}' = \vec{\nabla} \times [\vec{A} + \vec{\nabla} \lambda] \\ &= \vec{\nabla} \times \vec{A} + \vec{\nabla} \times \vec{\nabla} \lambda \\ &= \vec{B} \end{aligned} \quad \vec{\nabla} \times \vec{\nabla} = 0$$

④
$$\begin{aligned} \vec{E}' &= -\vec{\nabla} \phi' - \frac{\partial}{\partial t} \vec{A}' \\ &= -\vec{\nabla} \left[\phi - \frac{\partial}{\partial t} \lambda \right] - \frac{\partial}{\partial t} [\vec{A} + \vec{\nabla} \lambda] \\ &= -\vec{\nabla} \phi - \frac{\partial}{\partial t} \vec{A} = \vec{E} \end{aligned}$$

(\vec{E} and \vec{B}) do not

⑤ Thus, physical quantities under gauge transformation of ②. Gauge.

charge under gauge transformation of the mathematical dependence is an artifact of the mathematical construct involved in introducing ϕ and \vec{A} .

⑥ We will later show how gauge invariance is connected to conservation of charge.

IV Choice of gauge

$$\textcircled{1} \quad -\nabla^2 \phi - \frac{\partial}{\partial t} (\vec{\nabla} \cdot \vec{A}) = \frac{\rho}{\epsilon_0}$$

$$-\nabla^2 \vec{A} + \frac{1}{c^2} \frac{\partial^2}{\partial t^2} \vec{A} + \vec{\nabla} \left[\vec{\nabla} \cdot \vec{A} + \frac{1}{c^2} \frac{\partial}{\partial t} \phi \right] = \mu_0 \vec{J}$$

② Lorentz gauge is the choice.

$$\vec{\nabla} \cdot \vec{A} + \frac{1}{c^2} \frac{\partial}{\partial t} \phi = 0,$$

which used in $\textcircled{1}$ gives.

$$-\nabla^2 \phi + \frac{1}{c^2} \frac{\partial^2}{\partial t^2} \phi = \frac{\rho}{\epsilon_0}$$

$$-\nabla^2 \vec{A} + \frac{1}{c^2} \frac{\partial^2}{\partial t^2} \vec{A} = \mu_0 \vec{J}$$

and are inhomogeneous (with source) wave equation.

③ Coulomb gauge is the choice.

$$\vec{\nabla} \cdot \vec{A} = 0,$$

which used in $\textcircled{1}$ gives.

$$-\nabla^2 \phi = \frac{\rho}{\epsilon_0}$$

$$-\nabla^2 \vec{A} + \frac{1}{c^2} \frac{\partial^2}{\partial t^2} \vec{A} = \mu_0 \vec{J} - \frac{1}{c^2} \frac{\partial}{\partial t} \vec{\nabla} \phi.$$

This has the advantage that determination of ϕ does not contain time dependence.
